Change-of-Name Agreement

(2) Each party has executed this Agreement as of the day and year first above written.



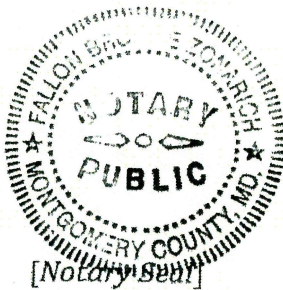
